

Conditions of participation

The following conditions of participation govern the contractual relationship between event participants and the Federal Institute for Materials Research and Testing (BAM).

§ 1 Organizer

The organizer is the Federal Institute for Materials research and Testing (BAM) Unter den Eichen 87, 12205 Berlin, hereinafter referred as "BAM".

§ 2 Registration

- (1) The registration for participation is done by logging in via moreEvent, the online participant management system of meetingmasters.
- (2) The entitlement to participate arises only after receipt of the confirmation of participation, which is sent to the e-mail address provided during registration.

§ 3 Conditions of participation

- (1) The participant is subject to the house rules of the venue during the entire event. The orders of the organizer are to be followed.
- (2) Participant in the sense of these Conditions of Participation is the natural person in whose name the binding registration is made and who is admitted as a participant by BAM.

§ 4 Cancellation

- (1) If you cannot attend the conference for unforeseeable reasons after registration, please send an e-mail to: sw@meetingmasters.de.
- (2) For cancellations after 16.05.2020 a cancellation fee of 70,00 Euro will be charged. For cancellation until 15.07.2020 a cancellation fee of 150,00 Euro is due. In the event of cancellation after 15.07.2020, no refund will be made.
- (3) BAM reserves the right to refuse admission to participants who have not paid the participation fee.

§ 5 Image and sound recordings

- (1) Image and sound recordings as well as other recordings and transmissions of the events of all kinds (radio, TV, Internet, loudspeakers etc.) also require the prior written consent of BAM, subject to the consent of copyright holders and ancillary copyright holders involved.

- (2) The BAM is granted the right to make or have made or have made audio/visual recordings of event sequences or exhibited or used objects for the purpose of documentation or for own publications (print and digital)
- (3) Furthermore, the participant agrees to the publication of the images for the purpose of reporting. The declaration of consent can be revoked at any time with effect for the future. In case of revocation, the person's recordings will be removed from the BAM homepage.

§ 5 Copyright law

- (1) The event-related lectures and documentation are protected by copyright and may not be reproduced, distributed or commercially used in any form – even in part – without the consent of the organizer and the respective speakers.
- (2) BAM accepts no responsibility or liability for any inaccuracies in the content of the lectures and documentation.

§ 6 Liability

- (1) BAM does not assume any duty of care for personal belongings.
- (2) BAM is only liable for damage caused by intent and gross negligence. Excluded from this limitation of liability are
 - negligently caused damage to property and financial losses due to the violation of an essential contractual obligation; essential contractual obligations are those whose fulfilment characterizes the contract and on which the contractual partner may rely. In the event of a breach of essential contractual obligations, however, BAM's liability is limited to the amount of damages foreseeable and typical for the contract at the time of conclusion of the contract.
 - damage due to injury to life and limb, body and health, provided that BAM is liable to pay compensation for such damage under statutory provisions.
- (3) Insofar as liability is excluded or limited under these provisions, this shall also apply to BAM's vicarious agents and assistants.

§ 7 Data protection

- (1) The personal data entered by the participant will only be used to the extent necessary for the booking and processing of participation in the event.

The data will not be passed on for other purposes. Furthermore, the legal data protection regulations are observed during data collection, storage and processing.

§ 8 Final provisions

- (1) Exclusive place of jurisdiction for all disputes arising from this contractual relationship is Berlin, provided that an agreement on the place of jurisdiction is legally permissible.
- (2) The law of the Federal Republic of Germany shall apply, excluding the UN Convention on Contracts for the International Sale of Goods.
- (3) Should any provision of these conditions of participation prove to be invalid in whole or in part, the remaining provisions shall nevertheless apply.
